Dreaming Big

My biggest dream is to resolve the climate crisis.

In February, I was one of more than 500 Third Actors who pledged to travel to Washington DC to hold three days of protests against development of more liquified natural gas terminals on the southern coast of the U.S. That was enough pressure for President Biden to put a pause on the permitting process. I consider our protests successful nonviolent direct action (NVDA).

In Third Act VT's April newsletter I mentioned my goal of bringing 100 of our members with me to the nonviolent direct actions in New York City this summer. The campaign is called the Summer of Heat on Wall Street.

Later this week I will go to an NVDA training with another TA VT member. We will be with leaders from other Third Act working groups in the Northeast who are preparing to confront CitiBank and other financiers of continued fossil fuel infrastructure development.

As of today there are half a dozen people from TA VT who said they are willing to join me in protests on Wall Street. We just need another 93 to reach my 100-member goal.


Even though bringing 100 TA VTers may feel impossible, it's what I've decided to try to do. I have a powerful vision of elders: getting up out of our rocking chairs, taking a stand for the sake of the planet and all the life it holds, including our grandchildren's future.


I am also fighting for a livable planet for myself, this year, here in Vermont. I am afraid for my garden, the forests I love, the quality of the air I breathe, and the water I drink as we face quickly rising global temperatures. I am afraid for our society that has not acted at a pace and scale sufficient to halt that rise in temperature.

I also feel afraid that my words and actions won't be large and strong enough to convince you to join me.

My dream scares me. Do I have enough time and energy to do everything I can think of to make my dream a reality? My dream scares me because I feel like I won't be able to control or predict what will happen. My dream scares me because I'm not sure whether you share my dream.

However, I know that I am not alone. Over the last few years I have heard Bill McKibben repeatedly say, "Climate change is the single biggest thing that hu-

A dozen people met in Putney on May 1 to learn how they can take action on climate and democracy with Third Act Vermont. We talked about the basics of our organization and the current campaigns. People got into small groups to consider how they might like to be involved.

In addition to the information session, we sang together, shared a potluck meal, and got to know each other a bit. Eight new people joined Third Act VT, and we all had a good time!



Postcards for Democracy Update

On Sunday, May 5, we had our third monthly postcarding event to support candidates and issues in key battleground states. There were in-person meetings in Chittenden and Windham counties, as well as at three sites in Massachusetts, one in Washington D.C., and one in Pennsylvania.

Cards went out in support of Ruben Gallego's U.S. senate candidacy in Arizona, and for current U.S. Senator Jon Tester of Montana. As we get closer to Election Day, the race targets will change as polls are updated and battleground state dynamics shift. So far, we have mailed just shy of 7,000 cards, and we hope to break the 20,000 mark by October.

Senior to Senior Voter Registration Update

Our numbers keep growing! Of the 91 public and private high schools in the state, Third Act VT members are helping young voters register to vote in 37 schools, and League of Women Voters is doing the same in 10 schools—for a combined total of 47. That's more than half of Vermont high schools!

With a one-hour, online training, any one of us can learn how to get the Senior to Senior project into schools in Vermont or in swing states. May is the perfect time to take action. Divestment Action Team Update

The Divestment Action Team (DAT) was ultimately unsuccessful in its efforts to get S.42, the fossil fuel divestment bill, voted out of the VT House Government Operations and Military Affairs Committee. DAT members, along with Vermont Treasurer Mike Pieciak, testified before the committee in support of the bill on April 11. But the committee also heard testimony in opposition to divestment from former Treasurer Beth Pearce on that day, as well as from the Vermont Pension Commission and labor groups on April 16. Unfortunately, much of their testimony either overlooked or misunderstood how the bill had been amended to address the Pension Commission's concerns. In the committee's discussion of the bill, and it became clear that a majority did not support it. The bill was therefore not voted out of committee for consideration by the full House, and it has "died" in committee for this legislative biennium.

The DAT is currently considering whether to reintroduce a new divestment bill next year, at the start of the new legislative biennium, or instead introduce a "decarbonization" bill, which was an approach the Pension Commission proposed as an alternative to divestment.

On the plus side, the DAT is proud of having moved a divestment bill closer to passage than at any time in the last decade. The team's advocacy for the bill has also been a great introduction for Third Act Vermont to the legislature and a great education for the team in how the state legislative process works. Through this work the team has built credibility with members of the legislature that will be very helpful for our future efforts.
