#### Fresh from the Summer of Heat on Wall Street Street

Eight Third Act VT members took part in the Summer of Heat on Wall Street protest on July 8, the second time we've participated in the series of events. This time, seven of us were arrested.

At the Citibank world headquarters in New York City, there was a somber tone. The protesters' speeches were like eulogies for all the people and life on Earth that has already



been lost due to climate disasters. There was a procession led by a bagpiper, and a graveyard was set up where each gravestone showed a person's name and the story of how they died from a climate disaster. Then, one woman sang a lamentation for the Earth. Eight Lamenters, dressed in sackcloth with ash on their faces, stood in solemn reminder of the perils of burning fossil fuels. We held a "die-in" at the main doors of Citibank, and many people laid down on the pavement in the noonday sun. Oddly enough, this was the action for which we were arrested. As we laid there a gong rang and facts about recent deaths were read in testament to the destruction that Citibank's business plan has brought about. (continued on page 2)

A common question people ask about such protests is "does such an action make any difference?" Bill McKibbens' short answer is that *everything* we do makes a difference. Third Act VT Facilitator Laurel Green believes "the place where it makes the most difference is in my own mind and heart." She and four more Third Act Vermonters shared what was most significant for them about participating in Summer of Heat on Wall Street.

"The action we did on Monday, July 8, was a funeral, but for me it was also a renewal. A renewal of hope, of energy, and of connection. The Summer of Heat team is so disciplined, so strategic and so prepared. The trainers and organizers were honest and upbeat. The event leaders designed an event that was both complex, with many interlocking parts, and simple in its impact—as simple as the single strain of bagpipe music that led our cortege. The jail support team prepared us, celebrated us, and took great care of us. Days later, I still feel the effects: of love, of hope, of gratitude, and of confidence in the change we can make collectively. My deep thanks to those who are leading us for-—Cynthia Maltbie, W. Newbury ward."

"My decision to take actions that put me at risk for arrest was made early this spring. When I laid down at the feet of the Lamenters, just outside the main doors of Citibank, I felt humble and at the same time determined. I felt vulnerable lying on the ground looking up at the noonday sun. The people on my right and left agreed to hold hands together. When the first gong sounded, I listened as one person read about the 1,300 heat deaths this year at the Hajj, an annual outdoor Muslim religious gathering. When the second gong sounded, someone read about the 30 thousand acres of forest burned last year in Canada. With the third gong and another reading, the words piled up on me like waves pounding the shore. Tears welled, and I sobbed overt the destruction of the precious life on our planet. Both people next to me squeezed my hands. We were in this together. I felt baked by the sun and tested in my determination. Yet I persisted until I was arrested."

"Experiencing the heat in a setting where I had no ability to control or escape it, limited as it was, felt like a small gesture of solidarity with the billions of people now experiencing it daily. As well, I felt united with our grandchildren who will suffer it soon if we are not successful. I also felt humbled and activated by the wonderfully articulate reminder of the indivisibility of all the justice issues plaguing our time and our people. Venceremos! We shall overcome!"

"The nonviolent direct action we did on July 8 was special in that it made an opening for climate grief. Many of our other actions have been boisterous, loud, demanding. By comparison this collective act of civil disobedience was quiet, slow, and meditative. I found this a challenge in some ways, as it was hard to discipline my own mind to stay steady in that space of acceptance. By acceptance I do not imply that we would cease to fight, but that we will continue the struggle even while we attempt to acknowledge all that we've lost and all that we are likely to lose in the future. I actually feel inspired to work harder now that I am consciously holding a space for all the people, animals, plants, species, and habitats that have perished in this hotter world, and I am determined to prevent as many future climate deaths as I can."

"I think all of us involved in this work have to some degree a well of despair, loss, pain, fear, anger. It

brushes us at odd moments, and we turn away, move on. It's so hard to face grief.

I volunteered to be one of the silent, downcast, sackcloth and ashes Lamenters for the July 8 action. It was a walking meditation, encased in silence, seeing only a few feet before me, cut off from the bustle. Walking slowly in the cortege behind the bagpiper, hands turned out, I reached that well of sorrow. I was holding the little bodies of my beloved grandchildren, unable to protect them. I was holding this precious, infinitely beautiful world as it's being brought to ruin by an overreaching, out-of-control species.

Meanwhile, it was hot. Every bit of shade or passing breeze was welcome. After standing still for so long, it was a relief when the Lamenters chose to lie down on the plaza to add to the arrest count, hot as it was on cement. With eyes closed against the fierce sun, I felt the sun was sending an urgent message: "I'm here, I'm free, I'm all you need. As for fossil fuels, 'Keep them in the ground!" Then there was a wonderful breeze, and I realized other protesters were fanning us with paper fans provided by the organizers. In times of sorrow all we need is here: the sun to give us life, our home on this good earth, and people who care for each other and our home. Knowing that is hope, but taking action brings hope to life."

## Third Act Protests Bank of America in Bedford, MA

In a Summer of Heat on Wall Street protest co-organized by the Third Act chapters of Massachusetts and New Hampshire, more than 70 seniors gathered in Bedford, MA on Tuesday, July 9. Their message to Bank of America: Stop using their savings to fund fossil fuel projects. Also joining were Barbara Thibeault and Michael Bosworth of Third Act Vermont (and TA Windham County), as well as another visitor from Maine.

It was a lively, fun, and peaceful protest, with cars honking in support, directly across the street from a Bank of America branch. Joining the group was Bill McKibbon's mother, Peggy, and participants from Mothers Out Front, 350.org, and Extinction Rebellion. Protesters presented a letter to the bank manager, who promised to pass it along to senior management.



# **Divestment Action Team Update**

The Divestment Action Team (DAT) has decided that a decarbonization bill would be the best way at this point to support Vermont's goal of reaching net-zero emissions in its pension portfolio. The DAT came to this conclusion after reviewing the unsuccessful efforts this year to pass divestment bills in Vermont and California, and the challenges that Maine has faced in trying to implement the divestment bill passed there a couple of years ago. The DAT also reviewed the New York City Employees Retirement System's Net Zero Implementation Plan, which appears to be a very robust plan focused on decarbonization, with a goal of net-zero emission by 2040. (The difference between divestment and decarbonization is that divestment requires divesting from fossil fuel holdings, while decarbonization seeks to reach net-zero emissions across the entire portfolio.) During the last legislative session, the Vermont Pension Investment Commission (VPIC) presented a decarbonization proposal during the hearings on divestment before the House Committee on Government Operations and Military Affairs. The DAT supported that proposal and continues to think it makes sense to support passage of some version of a decarbonization and net-zero plan. We will contact our allies for feedback on this new bill proposal. Our "elevator pitch" is that we support VPIC developing a plan to decarbonize its portfolio with a goal of achieving net zero by a specified date.



## **New Voting Action Team Forming**

No matter how the presidential race shakes out, our mission is clear: We <u>must</u> defeat Donald Trump, his MAGA followers, and the Heritage Foundation's *Project 2025*. We have less than four months before the all-important November elections. Not only will this election affect all of us in major ways but also future generations.

Third Act VT is forming a new Voting Action Team. Our goal is to mount a <u>multi-front effort</u>, including text banking, phone banking, post carding, and Letters to the Editor (in other states).

Third Act VT is already doing post carding to get out the vote. I have been doing a lot of text banking (3,000 texts since May). Several people have shown an interest in helping, including phone banking.

## **Brief History of Third Act Vermont**

Dec. 2021: The national Third Act organization (Third Act Central or TA C) was started, and Third Act Vermont (TA VT) started soon thereafter.

May 2022: Bank action at Chase in Burlington

June 2022: all Coordinating Committee (Coord Com) members stepped aside except Laurel Green. Help was requested from TA C, a survey was sent out, and Laurel used the results to recruit a new Coord Com.

January 2023: Laurel announced that she had to step back beginning in June, and a search began for a new cofacilitator.

March, 2023: Day of Action on the 21st at Chase in Burlington

May, 2023: Robert Small announced that he was stepping back from the cofacilitator role. The search for a new cofacilitator continued.

June, 2023: No new co-facilitators had stepped forward. The Coord Com decided to rotate leadership of Coord Com and statewide meetings and not to tackle the other co-facilitator tasks.

February, 2024: The Statewide meeting failed because of lack of redundancy in who could host the Zoom meeting, then a few Coord Com members stepped off the Coord Com.

March, 2024: Help was requested from TA C, and the Coord Com met with TA C staff member Melanie Griffth to triage the situation. Five avenues to recruit Coord Com members were pursued in full with calls and emails to TA VT members who were on the Legislative Action Team, the Divestment Action Team, the Regional Groups Organizers, Statewide Meeting frequent attenders, and anyone John Woodland flagged during "welcome to TA VT" calls who might consider a leadership role. One person volunteered for a minor role, then stepped back within a month.

June, 2024: At the Third Act New England Convergence, the Coord Com requested a special, in-person consultation with B Fulkerson, the national organizer. B's assessment was that we need to "surface" new leadership and restart TA VT.

July, 2024: The statewide meeting has been repurposed to initiate revitalization of TA VT.
