#### **Beware of Misinformation**

On July 24, Vermont House Speaker Jill Krowinsky penned a <u>press release</u> about Vermont's Affordable Heat Act (S.5) and a misinformation campaign by a Koch Brothers Super-PAC.

"There has been a significant and intentional misinformation campaign circulating across Vermont about the Affordable Heat Act," Krowinsky wrote. "Much of this information is coming from groups outside of Vermont, like Americans for Prosperity [AFP]." Founded by the Koch brothers, "...this Super-PAC has emerged as a leading defender of the oil and gas industry and a well-funded opponent of climate and environmental initiatives nationwide. In May 2024, AFP announced a 'major five-part mail and digital campaign' to target Vermont voters during this election cycle. AFP postcards, for example, include false claims that S.5 'mandates heat pump installations in homes,'" reads the press release.

"The Affordable Heat Act is an important step in ensuring that all Vermonters have access to low-cost, reliable heat and relief from the dramatic increases in heating fuel that we see year over year," Krowinsky wrote. Draft rules for the act are being developed and will be brought before the legislature for a transparent review. Learn more about the Affordable Heat Act and the legislative process here.

#### Summer of Heat on Wall Street

August 26-30, New York City

Interested in taking part in Non-Violent Direct Action (NVDA)? This month is a great time to do so!

The last week of August is the official final week of Summer of Heat on Wall Street, an escalating, multimonth NVDA campaign. The main goal is to end fossil fuels by cutting off their funding, insurance, and new-development permitting. Summer of Heat is organized by a wide ranging coalition of climate groups. There is thoughtful support available if you wish to help with everything from action design and housing to jail and court support.

Third Act is not planning the grand finale, but we are very welcome to join the <u>Third Act Faith Working</u> <u>Group</u> and <u>Green Faith</u> on Tuesday morning, Aug. 27, or on Friday, Aug. 30, to swell the crowd of activists making demands on Citibank.



According to the Summer of Heat website, demands include:

**Stop Funding Fossil Fuels.** Wall Street must stop funding, insuring, and investing in all coal, oil, gas, and petrochemical companies.

**Exponentially Increase Financing for Renewable Energy.** Wall Street must increase its level of financing for renewable energy so that it is in line with what is required for the world to limit global warming to 1.5 degrees Celsius (2.7 degrees Fahrenheit). According to research by ReclaimFinance, a non-governmental research and campaigning organization, this means that Wall Street banks must increase their level of renewable energy financing by at least a factor of six by 2030.

Respect Human Rights and Indigenous Sovereignty as Part of a Just Transition. From Arizona to the Congo, the energy transition risks driving a new wave of human rights abuses and violations of Indigenous sovereignty. Wall Street must ensure that human rights, Indigenous sovereignty, and the rights of workers are respected by every company they finance, including renewable energy and rare earth mining companies.

**Repair the Harm.** Wall Street must acknowledge its role in fueling climate chaos and environmental racism around the world and pay into a climate reparations fund, such as the Fund for Responding to Loss and Damage of the United Nations' Framework Convention on Climate Change. # **Senior-to-Senior Youth Voter Registration**

It's estimated that fewer than half of 18-year-olds are registered to vote! High school is the time and place to get it done. Third Act VT has an important role to play in welcoming young people into our democracy and instilling a lifelong interest in voting and good citizenship.

Join us in working with <u>Third Act</u> national and <u>The Civics Center</u> on this initiative. Learn more and preview the resources available to schools on The Civics Center's website. Third Act VT is also collaborating with the League of Women Voters of Vermont's (<u>LWVVT</u>) high school voter registration efforts.

As of May 2024, Third Act Vermonters were working on Senior-to-Senior in one-third of our high schools (out of 90 total schools). Our allies in the LWVVT were working in another 10 percent. Many report having fun, feeling satisfied with their work, and feeling pleased to promote this key action for democracy.

"Being part of the team that facilitated the voter registration drive at Middlebury Union High School was



## **Postcards for Democracy**

Our post-carding efforts targeted Pennsylvania voters, initially, to remind them to re-register for mail-in ballots. The state's requirement to re-register had been implemented to suppress voting. Since March, we have also used post-carding to support important campaigns in PA, AZ, MT, OH, NY, and CA. Our current focus is back to Pennsylvania.

We meet on the first Sunday of each month, from 2-4 p.m., in various locations (VT, DC, PA, and MA). You do not have to attend an in-person event to participate; you may participate remotely. We would welcome your participation in any way and at any level.

We have sent more than 14,000 post cards so far! We have two more Sunday events planned and a week-long marathon in October. Separate details, Zoom links, and reminders will be sent out ahead of any actions.

#### 15 Minutes for Our Future!

Mondays, 8:30 a.m., up to Election Day

As a complement to and outgrowth of our partnership with teams from battleground states, we have launched a weekly meeting and actions to protect our democracy—and by default, our climate and future. We're calling this "15 Minutes For Our Future!"

We are holding *brief* (less than 15-minute) weekly Zoom calls to identify two actions that each of us can take that week in support of democracy. These actions are easy, with clear instructions; fun; and fast—they can be completed in 15 minutes or less. And they require minimal effort for maximum impact.

At our first meeting, on August 5, we chose actions to support battleground candidates and to learn about Project 2025. At each upcoming meeting, we:

- will recap wins and accomplishments from the previous week (5 minutes), and
- present two new actions for the current week, including any support materials.

Program details, week-by-week actions and accomplishments, and any other pertinent information are available and current at the Third Act VT <u>15 Minutes For Our Future web page</u>.

Meetings are Mondays at 8:30 a.m. up to Election Day, and there's a hard stop after 15 minutes, though the moderator may stay on if they wish.

## **Divestment Action Team Update**

The Divestment Action Team (DAT) will meet with Becky Wasserman, director of Economic Empowerment in the Office of the State Treasurer, and State Treasurer Mike Pieciak to discuss a decarbonization proposal. The Vermont Pension Investment Commission (VPIC) presented the proposal as an alternative to Bill S.42 before the House Government Operations and Military Affairs Committee witness testimonies. Bill S.42 is an act relating to divestment of state pension funds of investments in the fossil fuel industry. DAT members Beth Sachs and David McColgin will meet with Representative Kate Nugent about this decarbonization proposal.

### **Changes Ahead Within Third Act Vermont**

This is a good time for retrospection. We have made strides as we follow our mission to inspire Vermont elders to take action on the climate crisis and democracy through education, advocacy, and camaraderie.

Internal to Third Act VT, we reconstituted the Coordinating Committee in 2022 and the group has functioned well. It established our Vision, Mission, and Values; has held monthly statewide meetings on the third Thursday each month; dealt with database and web page needs; and built connections with Third Act Central, just to name a few accomplishments.

Regarding our outreach efforts,

- we organized and hosted a very successful Banking on Our Future: Day of Action on 3.21.23,
- our Legislative Action Team and Divestment Action Team moved legislation through the Vermont House and Senate and developed working relationships with many legislators and allied organizations,
- we celebrated camaraderie at our Rendezvous in June, and
- some of us have participated in Summer of Heat on Wall Street nonviolent direct actions.

TA VT members are stepping up for action on democracy with postcarding, letter writing, conversational canvassing, Senior to Senior Voter Registration, and Regional Groups for local action. There are now regional groups in half the counties in Vermont, and three more are in development.

The work of the Coordinating Committee to surface new leadership is starting to bear fruit. Two TA VT members, who have been active in various roles, are about to become the new co-facilitators. It will be an honor to mentor them as they find ways for the new role to fit them.

Personally, I will be transitioning from the role of facilitator into a new role as the regional groups coordinator to continue that important work of organizational development. I appreciate each person who has put their time, energy, and thought into the past and current thriving of Third Act Vermont. I can proudly say I am pleased with us as a working group of Third Act.


#### Third Act Vermont Handout

Bill McKibben is an acclaimed environmental activist who founded the first global grassroots climate campaign, 350.org, and Third Act. He has written more than a dozen books about the environment, including his first, *The End of Nature*, published in 1989. In 2014 he was awarded the Right Livelihood Prize, often referred to as the alternative Nobel. He has won the Gandhi Peace Award, holds honorary degrees from 19 colleges and universities, and currently serves as the Schumann Distinguished Scholar Environmental Studies at Middlebury College in Vermont.
